CONDITIONS OF SALE

SELLER'S OBLIGATIONS/GUARANTEES

1. This Beagle is guaranteed to be healthy at time of sale. Buyer is to have Beagle examined by reputable veterinarian within 72 hours of purchase. Buyer assumes all responsibility for any health concerns arising after this 72-hour period has elapsed.
2. Seller agrees to provide assistance and advice necessary in educating Buyer regarding care, grooming, and training of the said Beagle
3. Seller agrees to provide a four-generation pedigree, AKC individual registration application and an immunization/worming record.
4. This is not a guarantee, but an obligation to let the buyer know, that beagles, as well as other breeds, are prone to a condition called "cherry eye." This is when one of the tear glands pops up in the corner of the eye. Sometimes it can be taken care of with antibiotic ointment. If that doesn't work, a vet can either remove it or stitch the gland back under the eye followed by a course of antibiotic ointment. Either one is acceptable.
5. Seller guarantees that the puppy is free of hereditary defects to the best of their knowledge. The Seller does not assume any additional liability for the possible genetic defects in the puppy, and will under no circumstance be responsible for veterinary bills resulting from such condition.
6. The Sellers will use their best judgment in evaluating the puppies as to show or pet quality. There is no guarantee that a puppy evaluated as "Show Quality" will be successful in the show ring as a puppy or adult and no warranties are made to that effect. The Seller encourages owners to participate in the sport of purebred dogs and may be available to assist Buyer in preparing and showing dogs, which are evaluated to be of show quality.

BUYERS'S OBLIGATIONS/GUARANTEES

1. Buyer agrees to provide said Beagle with proper food, shelter, fenced yard and to keep said Beagle on a leash at all times when out in open spaces. Buyer agrees that Beagle will never be tied up in a yard at anytime.
2. Buyer agrees to provide veterinarian care including completion of immunizations, plus rabies.
3. If said Beagle is purchased as Show/Breeding stock, Buyer agrees to maintain Beagle in show condition and, given proper opportunity to do so, show puppy to its AKC Championship. Conformation classes can be started at 4 months of age, showing dog starts at 6 months of age, if ready.
4. Buyer **SHOULD NOT** breed said beagle.
OR (check box above for pet quality puppy **OR** check box below for show quality puppy)
4. Buyer **SHOULD NOT** breed said Beagle until it completes its Championship. Buyer will use discretion in breeding said Beagle and seek advice from Seller. Buyer agrees that all puppies resulting from any breeding of this Beagle will be placed individually in good homes and that none of the puppies shall be sold to a pet shop, retailer, wholesaler, or puppy mills.
5. Buyer agrees, if for any reason they cannot keep this Beagle, they are to notify Seller, who retains the first right to take this Beagle back, but not necessarily at the full price. After 6 months of age, payment may not be made. Seller may assist in reselling said dog. Selling this Beagle without first contacting seller **OR** to a puppy mill is strictly forbidden.

MUTUAL AGREEMENTS

1. Any dispute arising under this agreement will be mediated by a third party and/or appropriate court.
2. Failure to comply with any of the above conditions entitles Seller to damages in the amount of \$250.00 for each violation
3. If violations occur, Seller has the right to full ownership transferred to them, immediately.
4. Buyer must notify the Seller of any address change.

WE UNDERSTAND THE AFOREMENTIONED TERMS AND CONDITION AND AGREE TO ALL THE STATED CONDITIONS HEREIN, UNLESS OTHERWISE NOTED.
